### **CRIME ALERT**

Posted: November 29, 2012

On Saturday, November 24, 2012 at 1430 hrs; it was reported to the University Department of Public Safety that between 11/21/2012 and 11/24/2012 that an unknown person(s) had entered a Lobo Village #2 residence taking a television and a game station (Play Station 3) without the owner's effective consent.

## **CRIME ALERT**

**Posted: October 11, 2007**

On October 10, 2007 at approximately 0325 hrs; Alpine Police Department received a 9-1-1 call from a Sul Ross State University Student who requested assistance at Lobo Village #1/Graves Pierce. Upon arrival, Officers were advised by the student that a known African American male subject allegedly had broken into her off-campus residence, attempted to sexually assault her, followed her to the University campus making physical contact with her, and had just entered Lobo Village #1. At approximately 0349 hrs, Brewster County Sheriff's Office located the male subject at Alpine Heights. The Alpine Police Department charged the male subject with the offense of "Burglary of a Habitation with Intent to Commit Sex Offense". Charges are pending against the male subject for the offense of "Criminal Trespass" as he was prohibited from being on Sul Ross State University property.

On October 11, 2007 at approximately 4:00 p.m., UDPS Officers obtained "Warrant #AW-07-45 – Criminal Trespass" from the Brewster County Justice of the Peace office.

On October 12, 2007 at 1:35 a.m., UDPS Officers served warrant on male subject at Alpine Heights, placed him into custody, and transported him to the Brewster County Jail where he was released to the custody of Detention Officers. Criminal Trespass case has been filed with Brewster County Attorney's office.

## **CRIME ALERT**

Posted: October 9, 2007

On Monday, October 8, 2007 at approximately 9:05 p.m., it was reported to the Alpine Police Department by an adult female who advised she had been en route to her Alpine Heights apartment when she observed a tall black male wearing a white muscle shirt and shorts with white Nike shoes and a Hispanic male wearing a blue button up shirt with blue jeans in the parking lot. She further advised that she was going up the stairs to her apartment when the two male subjects started following her. She stated that she opened the door to her apartment and tried to slam it but the black male stuck his shoe in between the door and the door frame so the door wouldn't close. She further stated the male subject tried to push the door open and was trying to get in the room. She advised she kicked his foot, slammed the door on his hand, and was finally able to close the door. She advised the two male subjects had been in an old black or dark blue Cadillac being a low rider with tinted windows.
