

PAYMENT OPTIONS FOR TUITION, MANDATORY FEES, ROOM AND/OR BOARD

Sul Ross State University offers two payment options, including one installment plan, for the payment of tuition, mandatory fees, room and/or board. Optional fees and deposits are due and payable at the time the service is rendered or contracted for. To qualify for the installment plan, a student must first apply all University awards, scholarships, loans (University, state or federal) and grants (University, state or federal) to the total amount due the University. The University will apply these monies to tuition and mandatory fees, and rent, room and/or board.

Installment options are subject to change by the Texas Legislature and / or the Board of Regents.

NO BILLS WILL BE MAILED. If on the installment plan, the student must sign at registration a promissory note which will contain a schedule of payment amounts and due dates. The full amount due plus the applicable fee may be paid at any time before the due date. The installment amount due is payable no later than 4:00 p.m. on the due date.

If not paid by the due date a late fee of \$15.00 will be assessed.

A student who fails to make full payment of tuition and fees, including any incidental fees, by the due date may be prohibited from registering for classes until full payment is made. A student who fails to make payment prior to the end of the semester may be denied credit for the work done that semester. If a room payment is late, the student will be referred to the Director of Residential Living. If a board payment is late, the student will be referred to the Dean of Student Life. Students are also subject to other actions outlined under Penalties for Failure to pay in the student handbook.

WITHDRAWALS

Students officially withdrawing from the University must pay all tuition, mandatory fees, room and/or board owed at the time of withdrawal. Students who fail to pay the amount due upon withdrawal shall have their transcripts held and may not be eligible to re-enroll if their balance due is \$500 or more.

NON-PAYMENT OF TUITION and FEES

Students who have not paid the required tuition and fees either out of pocket or with financial aid **by** the last day of late registration of each semester may be dropped from all classes. Students who do not enroll in classes before the first class date of each semester will be charged a Late Registration Fee of \$125.

STUDENT APARTMENTS

Apartment rent is due and payable in full at the time of registration or may be made in installments each semester. The university will apply all financial aid to pay apartment charges for the entire semester, which will be posted to the student's account on the first day of class. Installment plans are available each semester through Enrollment Services. Students are also subject to other actions outlined under Penalties for Failure to Pay in the student handbook. All University awards, scholarships, loans (University, state or federal) and grants (University, state or federal) will be applied to the total amount due the University for that semester.

REFUNDS

Refund of Fees. Any student who has paid the registration Fees and officially withdraws by submitting a withdrawal form is entitled to a refund of tuition and fees as follows:

Session length 10 weeks or greater:

Prior to the first regularly scheduled class day	100%
During the first five class days	80%
During the second five class days	70%
During the third five class days	50%
During the fourth five class days	25%
After the fourth five class days	None

Session length 5+ weeks to 10 weeks

Prior to the first regularly scheduled class day	100%
During the first, second or third class day	80%
During the fourth, fifth or sixth class day	50%
Seventh day of class and thereafter	None

Should a student reduce his/her semester hours by officially dropping a course or courses, the following refund rates will apply, provided the student remains enrolled at Sul Ross State University:

Regular Session

During the first twelve class days	100%
After the twelfth class day	None

Summer Session

During the first four class days	100%
After the fourth class day	None

These rates apply to total tuition and fee charges for the semester. A class day is a regular day of class at the University. The first twelve class days are the first twelve days of regular class meetings on the University campus. An immediate refund will not be made at the time a student withdraws or reduces his/her hours during a semester; however, a direct deposit covering all refunds due will be processed within approximately 30 days. The University reserves the right to audit all assessed fees and bill or refund accordingly.

The refund policy as noted above is subject to change.
